

END USER LICENSE AGREEMENT

YOU SHOULD CAREFULLY READ THE FOLLOWING TERMS AND CONDITIONS OF THIS END USER LICENSE AGREEMENT (THIS “AGREEMENT”) BEFORE YOU USE THIS SOFTWARE. GELLER DATA SOLUTIONS, INCORPORATED (“LICENSOR”) IS LICENSING THIS SOFTWARE TO YOU FOR YOUR USE ONLY AS SET FORTH BELOW. BY USING ANY PART OF THE SOFTWARE, YOU INDICATE THAT YOU HEREBY ACCEPT AND AGREE TO ALL OF THE TERMS AND CONDITIONS OF THIS AGREEMENT. IF YOU DO NOT AGREE TO BE BOUND BY THE TERMS AND CONDITIONS OF THIS AGREEMENT, YOU SHOULD NOT USE OR INSTALL THIS SOFTWARE AND PROMPTLY RETURN THE APPLICATION IN THE FORM IT WAS DELIVERED TO YOU.

1. Grant of License.

(a) Licensor hereby grants to you, and you hereby accept from Licensor, a personal, non-exclusive, non-transferable license to use the software that you have been given (the “Software”) and any accompanying documentation (the “Documentation”), subject to, and only as authorized in, this Agreement. The Software and Documentation, including all data or images incorporated in or generated by the Software and Documentation, is licensed, not sold, to you. By the license granted to you hereunder, you understand and acknowledge that Licensor does not transfer to you title to or any of Licensor’s rights or interest in or to the Software or Documentation or any component part thereof except as expressly set forth herein, and under no circumstances shall this Agreement be considered a “sale” of the Software or Documentation or of any component part thereof to you. As more particularly described herein, Licensor retains full and complete right and title to the Software and Documentation and all component parts thereof and to all intellectual and industrial property rights therein, subject only to the limited right of use granted to you hereunder, which right of use Licensor may terminate or revoke in accordance with the terms of this Agreement.

(b) This Agreement permits the Software to be accessed and used, for a period of time as agreed upon per the Software Purchase, Software Toolkit or Software Per Use agreement, that is owned, leased or otherwise controlled by you. The installation, network or use of the Software on more computers than the number agreed to is not permitted without separate authorization by Licensor and the possible payment of additional license fees. You may make one copy of the Software on a second set of diskettes (or on cassette tape or CD-ROM disk) for the sole purpose of backup in the event the original medium on which the Software is recorded is damaged or destroyed. You may also make one copy of the Documentation for backup purposes. Any such copies of the Software or the Documentation shall include Licensor’s copyright and other proprietary notices. Except as authorized under this Section 1(b), no copies, clones or duplicates of the Software and Documentation or any component part thereof may be made by you or any person under your authority or control.

2. Restrictions. You acknowledge and agree that the Software and Documentation and all component parts thereof contain copyrighted material, trademarks, trade secrets, and other proprietary material of Licensor protected under applicable U.S. and international intellectual and industrial property laws (regardless of whether such rights of Licensor are registered or unregistered). You agree that, except as provided for in Section 1(b) above, you will not: (i) copy, modify, network, rent, lease, re-sell or otherwise distribute the Software or Documentation or any of its or their components; (ii) make the Software or Documentation available by “bulletin boards,” on-line services, remote dial-in, or network or telecommunications link of any kind; (iii) create derivative works or any other works that are based on or derived, in whole or in part, from the Software or Documentation or any of its or their components; (iv) assign, sublicense, transfer, pledge or otherwise share your rights under this Agreement; or (v) decompile, reverse engineer, disassemble, translate the Software or otherwise reduce the Software to a humanly perceivable form. The trademarks, service marks or logos used on the Software and/or Documentation are owned by Licensor or third parties who have granted limited rights of use to Licensor, and all rights therein are reserved by the respective owners. You will not alter or remove any trademarks, copyrights or other proprietary rights notices contained on the Software or the Documentation.

3. Term. This Agreement is effective upon your acceptance of its terms, as indicated by your accessing or otherwise using the Software, and shall continue in effect until terminated or the end of the lease agreement. You may terminate this Agreement at 3 months by returning the Software and Documentation and all copies of all component parts thereof and portions thereof. Licensor may terminate this Agreement immediately, without notice, if you fail to comply with any provision of this Agreement. In the event of any such termination, you agree that you will return the Software and Documentation and all copies of all component parts thereof and portions thereof within five (5) days after such termination.

4. **Limitation of Liability**

(a) **Limited Warranty.** THE SOFTWARE IS PROVIDED ON AN “AS-IS” BASIS WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE WARRANTIES AGAINST MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. ALL WARRANTIES AGAINST INFRINGEMENT ARE HEREBY DISCLAIMED EXCEPT LICENSOR REPRESENTS THAT IT HAS SUFFICIENT AUTHORIZATION TO LICENSE THE SOFTWARE TO YOU. LICENSOR DOES NOT WARRANT THAT THE FUNCTIONS CONTAINED IN THE SOFTWARE MEET YOUR REQUIREMENTS OR THAT THE USE OF THE SOFTWARE WILL BE UNINTERRUPTED OR ERROR FREE. IN NO EVENT WILL LICENSOR BE LIABLE TO YOU FOR ANY DAMAGES, INCLUDING ANY LOST PROFITS, LOST SAVINGS, OR OTHER INCIDENTAL OR CONSEQUENTIAL DAMAGES, RELATING TO THE USE OF OR INABILITY TO USE THE SOFTWARE, EVEN IF LICENSOR HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES, OR FOR ANY CLAIM BY ANY OTHER PARTY. THE FOREGOING LIMITATIONS OF LIABILITY ARE INTENDED TO APPLY WITHOUT REGARD TO WHETHER OTHER PROVISIONS OF THIS AGREEMENT HAVE BEEN BREACHED OR PROVEN INEFFECTIVE. LICENSOR MAKES NO WARRANTY OR REPRESENTATION THAT ITS SOFTWARE WILL WORK IN COMBINATION WITH ANY HARDWARE APPLICATIONS OR SOFTWARE PRODUCTS OF THIRD PARTIES, OR THAT ALL DEFECTS IN THE SOFTWARE WILL BE CORRECTED. THE SOFTWARE MAY INCLUDE OR BE BUNDLED WITH THIRD-PARTY SOFTWARE, THE USE OF WHICH IS GOVERNED BY A SEPARATE END-USER LICENSE AGREEMENT. THIS WARRANTY DOES NOT APPLY TO SUCH THIRD PARTY SOFTWARE. FOR APPLICABLE WARRANTY INFORMATION, PLEASE REFER TO THE END USER LICENSE AGREEMENT GOVERNING THE USE OF SUCH SOFTWARE OR THE ACCOMPANYING DOCUMENTATION RELATING TO SUCH SOFTWARE.

(b) **Exclusions.** THIS WARRANTY DOES NOT COVER, AND LICENSOR WILL NOT BE LIABLE FOR AND DOES NOT ASSUME ANY RESPONSIBILITY FOR, ANY BREAKAGES, DAMAGE, OR FAILURES CAUSED BY MISUSE, ABUSE, ACTS OF GOD, NEGLIGENCE, ACCIDENTS, IMPROPER INSTALLATION OR OTHER CAUSES BEYOND LICENSOR’S CONTROL. LICENSOR EXCLUDES AND WILL NOT PAY ANY INCIDENTAL AND CONSEQUENTIAL DAMAGES, SUCH AS ANY LOSS, EXPENSE OR DAMAGE OTHER THAN TO THE SOFTWARE ITSELF THAT MAY RESULT FROM A DEFECT IN THE SOFTWARE. SOME STATES DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU. Any court of competent jurisdiction over Licensor shall have jurisdiction over all conflicts arising from or in connection with this Agreement or the use of the Software and Documentation. Should any provision of this Agreement be declared unlawful, void or unenforceable by any court of competent jurisdiction, such provision shall be deemed severable from this Agreement and shall not affect the validity and enforceability of any remaining provisions hereof. If any action is brought by either party to this Agreement against the other party regarding the subject matter hereof, the prevailing party shall be entitled to recover, in addition to any other relief granted, reasonable attorneys’ fees and expenses of litigation. The failure of either party to enforce any rights granted hereunder or to take action against the other party in the event of any breach hereunder shall not be deemed a waiver by that party as to subsequent enforcement of rights or subsequent actions in the event of future breaches. This Agreement constitutes the entire agreement between you and Licensor relating to the subject matter herein and shall not be modified except in a writing signed by both parties. You acknowledge and agree that any violation by you of the provisions of this license would cause Licensor irreparable harm for which Licensor would have no adequate remedy at law; and that, in addition to other remedies which may be available to Licensor, Licensor will be entitled to seek injunctive relief, without the necessity of posting bond, against any such violation.
